



LOCAL RULE 27


The Parma Municipal Court herewith adopts the following Rule 27 as a Local Rule of Court effective August 1, 2014. A copy of this Rule will be filed with the Supreme Court of Ohio in accordance with Superintendence Rule 5. This Court shall afford notice and opportunity for comment hereafter.

The Court determines that there is an immediate need for the rule adoption to expedite the use of an electronically produced ticket in the Parma Municipal Court jurisdiction. The Ohio Highway Patrol is leading a pilot project that may replace the traditional traffic ticket with either a hybrid ticket or paperless e-ticket generated from a computer.


Local Rule 27. Use of electronically produced ticket.

(A) Authorization. The use and filing of a ticket that is produced by computer or other electronic means is hereby authorized in the Parma Municipal Court. The electronically produced ticket shall conform in all substantive respects to the "Ohio Uniform Traffic Ticket" set forth in the Ohio Traffic Rules' Appendix of Forms. If an electronically produced ticket is issued at the scene of an alleged offense, the issuing officer shall serve the Defendant with the Defendant's paper copy of the ticket as required by Rule 3 (E) of the Ohio Traffic Rules.

(B) **Form of Affidavit.** In every case in which an electronically produced ticket is used and filed, the ticket shall use forms that are substantially similar to Form 27.01-A (Court Record) and Form 27.01-B (Abstract).
